Study session to consider a proposed 28-unit, townhouse style, subdivision that would replace four existing single family residences on a site designated in the General Plan for medium density multi-family residential use (20-29.9 units per acre). The proposed density

would be approximately 25.2 units per net acre when all four existing parcels are combined. Preliminary development plans for the site indicate that the residential units would be three stories in height (maximum proposed height of 39 feet) and located in six buildings, each with individual two car garages, with access from a newly improved private street on the project site. The zoning for the site is *Planned Unit Development PUD 410* and the site is comprised of Assessor's Parcel Number's: 149-100-042, 043, 062, 064. No action will be taken since this is a study session.
