The applicant is requesting approval for improvements to an existing entry way into Sun Valley Shopping Center, including landscape modifications, lighting modifications and installation of one 18-foot tall monument sign within the median. The landscape improvements include expanding existing landscape areas, relocating one tree, removing 16 trees, the planting 56 new trees. Originally, the applicant also proposed a new wayfinding sign in front of the existing Mervyn's site; however the applicant has decided to not include the wayfinding sign in their application. The zoning designation is *RB - Retail Business*.

The site consists of two parcels, at 1.71 and 8.04 acres. The assessor's parcel numbers are 153-230-003 and 153-230-005.
