PUBLIC HEARING ITEM

1. PLN 16-0380, FOUNTAINHEAD DAY CARE, ARCHITECTURAL REVIEW PERMIT, AT 1715 & 1725 OAK PARK BLVD.

Public Hearing to consider approval of PLN 16-0380 for an Architectural Review Permit, submitted by AD Architects Inc., for a general day care (Fountainhead) facility for up to 72 children. The project would include removal of two existing buildings that were used for two separate daycare facilities on the site and the construction of a new building (approximately 5,000 square feet) with new site landscaping (including tree removals), parking areas, and outdoor play areas. The site is zoned *R-10 Single Family Residential*. Assessor's Parcel Numbers 170-071-008 & 009.

CEQA: Exempt, (Class 2 – Replacement and Reconstruction, Class 3 – New Construction or Conversion of Small Structures and Class 32 – Infill Development).
