Public hearing to consider approval of Minor Use Permit PLN 19-0061, submitted by Livewire Gaming Café. Section 18.25.100 of the Zoning Ordinance requires minor use permit approval for any *Commercial recreation and entertainment* use within an *RB - Retail Business* zoning district. The proposed use would occupy 1,579 square feet within an existing 13,120 gross square foot one-story, multi-tenant building. Proposed operating hours: Sunday thru Thursday, 10:30 am to 10:00 pm, Friday thru Saturday, 10:30 am to 2:00 am. The three-parcel site area is approximately 2.47 acres, zoned RB-Retail Business; APNs 153-081-012, 153-081-014 and 153-081-015 at 702-714 Contra Costa Boulevard.
