## **PUBLIC HEARINGS**

1. PLN 19-0367, ELLINWOOD APARTMENTS PARKING & LANDSCAPE MODIFICATIONS, 200-800 LONGBROOK WAY

An Architectural Review Permit request to modify, restripe and expand existing parking lots along the southwest and southeast portions of the Ellinwood Apartments site. The two subject parking lots would increase parking at the site, to 133 parking spaces, (from the current 126 parking spaces). The request includes landscape improvements along the Longbrook Way street frontage, including tree removal and replacement. The applicant will also be requesting a Use Permit request for reduced perimeter landscape width and reduced distributed landscape area that will require review and approval by the Planning Commission. Assessor Parcel Number: 127-210-014.
